

INVITATION TO BID

The Ministry of Economy and Finance

Wishes to Purchase:

Leased Line and Dedicated Internet Connectivity

1. The FMIS project Management Working Group (FMWG) has received Fund from the Royal Government of Cambodia (RGC) through the Public Financial Management Reform Program (PFMRP) of the Ministry of Economy and Finance (MEF) toward the cost of Financial Management Information System Project, and it intends to apply part of the proceeds of this to payments under the Contract for CAM-MEF-PFMRP-FMIS-N002-03.

No	Item	Description
1	Leased line Connectivity	The connectivity required two different links (one is main link with 8 Mbps bandwidth and another one is backup link with 5 Mbps bandwidth) for each site with MPLS. There will be 28 Installation sites located in Phnom Penh Capital City at the late of 2017 and will continue to all provinces in 2019.
2	Dedicated Internet Connectivity	The connectivity required three links of dedicated internet access; 1 st link required 10Mbps bandwidth, 2 nd link required 2Mbps bandwidth, and 3 rd link required 2Mbps bandwidth. There will be two installation sites located in Phnom Penh Capital City.

2. The goods are required by 1 week from the date of the signed contract.
3. Interested qualified eligible suppliers are invited to obtain a copy of the bidding documents free-of-charge from the address given below by submitting a written application. Except for the submission of a written application, there shall be no other conditions for obtaining the bidding documents.
4. To be considered eligible and qualified a bidder must
 - i) Have completed at least 1 leased line contract and 1 dedicated internet connectivity contract in the preceding 3 years of each contract price not less than 50% of the submitted bid price.
 - ii) Have completed contracts with a total cumulative value equal to at least two times the value of the submitted bid price during the preceding 3 years.

- iii) Not be under any notice of disbarment issued by the Government or DPs.
5. Bids must be delivered to the address given below at or before November, 13th 2017 at 10:00 AM. Late bids will be rejected. Bids will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
 6. The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
 7. All bids must be accompanied by a bid and performance securing declaration as described in the bidding documents. Any bid not accompanied by one will be rejected as non-compliant
